



Step 1: Turn on transmitter/receiver





Step 2: Insert microphone/earpiece

Insert the microphone to the MIC jack on the

transmitter, and insert the earpiece to the Earpiece jack on the receiver. Note: DO NOT insert Microphone/Earphone wrongly into charging port to avoid damage the charging pin inside.




Step 3: Adjust Volume

Press the Power Button [] when the VOL icon appears on the display, press the Up Button [1] to turn up the volume, and press the Down 10 volume levels of the transmitter and receiver.

Channel Synchronization

This is the faster way to set the channels for transmitter and receiver. You could synchronize the channel by operating the transmitter instead of changing the channel of the receivers one by one. A. Press the Power Button [] on the transmitter. the CH icon will appear on the display B, Press Up [] or Down [] button to select the channel that you want to use

C, Then long press the Up Button [] and observe the screen of the receiver, release the Up Button [] after the channel on the receiver is changed. Then channel synced successfully. Note: When you set the channel synchronization, please make sure the receiver is turned on and within 5m from the transmitter.
